



Call for expressions of interests to participate in a call for tenders

This publicity aims to alert the economic operators on the market that a call for tenders will be launched. The main information relating to this invitation for expression of interests is set out below.

Title: Data protection services

Reference: FCH / Contract 294

Type of call for tenders: Negotiated procedure for a middle value contract (point 14 of the EU Financial Regulation 2018/1046)

Description of the services/supplies to be purchased:

Under article 89(1) of Regulation (EU) 2018/1725¹, the Joint Undertakings, as separate controllers, have performed a data protection impact assessment in relation to future “cloud-based services” (i.e. Microsoft Office 365 and Azure Active Directory) the Joint Undertaking intend to license.

The data protection impact assessment foresees a series of mitigation measures to be taken from the IT perspective, HR, document management or data protection perspectives. The joint undertaking intend to contract the services necessary for implementing a part of the said mitigation measures related to data protection.

Participation in this call for tenders

Participation in this procurement procedure is open on equal terms to all natural and legal persons coming within the scope of the Treaties.

It also open to all natural and legal persons established in Overseas Countries and Territories (OCT) as listed in the Annex II of the TFEU and to all natural and legal persons established in Iceland, Norway and Lichtenstein, as per the EEA Agreement.

Notice for tenderers established in the United Kingdom

Please be aware that following the entry into force of the EU-UK Withdrawal Agreement² on 1 February 2020 and in particular Articles 127(6), 137 and 138, the references to natural or legal persons residing or established in a Member State of the European Union are to be understood as including natural or legal persons residing or established in the United Kingdom. UK residents and entities are therefore eligible to participate under this call for tenders.
